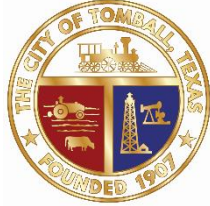


**NOTICE OF SPECIAL JOINT MEETING OF THE TOMBALL CITY
