

- **Cleaning and Sanitation:** Clean and sanitize park restrooms, ensuring all facilities are user-friendly. Empty trash cans and pick up litter throughout various parks. Sweep, mop floors, and clean countertops in park facilities.
- **Landscaping:** Mow grass and maintain clean edges along sidewalks. Operate weed eaters to maintain areas around buildings and other structures. Engage in gardening tasks such as trimming bushes, planting shrubs and flowers, weeding, and mulching.
- **Tree Maintenance:** Trim trees using chainsaws and bucket trucks, focusing on low hanging branches, dead limbs, and saplings.
- **Irrigation System Maintenance:** Ensure all plants and shrubs receive adequate water by checking and maintaining sprinkler systems. Replace broken sprinkler heads and repair timers.
- **Equipment Operation:** Operate a variety of parks maintenance equipment as required.
- Contribute to the team effort by performing other related duties as assigned.
